

1 Day ISPS Code & MTOFSA Awareness For Maritime Industry Executives

ISPS Code & Australian MTOFS Act & Regulations 2003. Syllabus based on the IMO Model Course 3.25 (2011)

This short and interactive course is delivered nationally by Scott McEwan AFNI, a former shipping industry executive with over 50 years of maritime industry involvement. His specialising in implementation of the ISPS Code and its associated codes, legislation and regulations commenced late in 2003, when the Code was conceived.

Aims

To enhance security-related knowledge of a senior executive with ultimate responsibility for their organisation's maritime or offshore security management system development and ongoing maintenance.

Topics covered include:

- Current maritime security threats and vulnerabilities – global, regional and local
- ISPS Code & of the MTOFS Act & Regulations (2003) objectives, requirements and obligations
- Understanding the roles of:
 - Government: its designated authority (Dept of Home Affairs)
 - Ships: Company Security Officer, Ship Master, Ship Security Officer & other seafarers
 - Ports: Port and Facility Security Officers
 - Offshore: Head and Offshore Facility Security Officers
 - Persons with designated security duties: Guards & Passenger Screening Officers
 - Responders: State / Territory Police and ABF
- Maritime security zones: land-side, water-side, cleared (passengers), ship (navigating or anchored) and offshore – purpose, access controls, signage, monitoring and MSIC requirements
- Security measures application – physical, technical and manpower
- Maritime security levels 1, 2 & 3 and minimum security measures generally applied at each level
- Recognition, on a non-discriminatory basis, of persons posing a security risk incl trusted insiders
- Responding to security threats including cyber
- Critical infrastructure requirements
- Mandatory maritime and cyber security incident reporting obligations and penalties for failure

Who should attend

Senior managers who provide necessary support for a Port / Port Facility Security Officer and wish to obtain a general understanding of port or offshore facility security risks, vulnerabilities, mitigation measures, responses and compliance obligations.

Entry standards

Knowledge of Quality and / or OH&S management systems would be useful but is not essential.

Locations & size

Courses are delivered at Pelagus' venues or in-house.

For maximum learning and interactivity, class size is limited to 6.
